

Console Surveys Competition

Terms & Conditions

1. To be eligible to enter this Competition, a participant must:
 - Be over the age of seventeen (17) years;
 - Be an Australian or New Zealand resident;
 - Complete the online research activities linked to this competition between AEST 12.00 am on Friday 18 January 2019 and AEST 11.59 pm Friday 1 March 2019;
 - Enter the competition no more than once per survey;
 - Be working in the real estate industry;
 - Provide accurate personal details at the end of the online activity; and
 - Comply with the terms and conditions listed here.
2. Employees of Console (and their immediate families) and agencies associated with this competition are ineligible to enter.
3. Only one (1) entry will be accepted per person per survey. An entrant may not submit multiple entries per survey.
4. Incomplete, indecipherable or illegible entries will be deemed invalid. No responsibility is accepted for late, lost or misdirected entries.

and another winner will be selected and notified as set out in these Terms and Conditions.

10. The prize winners do not have to be present at the time or place of the draws.
11. The Prizes are not transferable, refundable, and exchangeable and cannot be taken for cash.
12. If the Prizes are unavailable, the Promoter, in its absolute discretion, reserves the right to substitute the Prizes with a Prize to the equal value and/or specification.
13. The Promoter's decision as to the winners of a Prize is final and binding and no correspondence will be entered into in relation to the conduct of the Competition or otherwise.
14. The Promoter reserves the right, at any time, to verify the validity of entries and entrants and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of these rights.
15. If the use of the Prize is subject to the terms and conditions of a third party (including validity period), any dispute in relation to those terms and conditions must be directed to that party and the Promoter has no responsibility for resolving such disputes.
16. The Promoter is not obliged to publish the results of the Competition. Unless otherwise advised by the participant, by entering this Competition, participants agree to the Promoter publishing their name and image as a winner.
17. If this Competition is interfered with in any way or is not capable of being conducted as reasonable anticipated due to any reason beyond reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by the law to (a) disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Competition, as appropriate.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft,

unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize.

19. Each entrant indemnifies and keeps indemnified the Promoter against all claims, losses or damages and expenses suffered by the Promoter or any third parties arising out of the breach of these Terms and Conditions, the conduct of the entrant in the Competition or the use of the Prize.
